Educational Funding Sources for Seniors

★ Federal Financial Aid - FAFSA

- Traditionally opens October 1st of every year
- For current seniors, FAFSA probably won't open until December 31st
- There are things to do in advance of its release that will make completion easier

★ Idaho Launch

- New educational funding source for Idaho citizens
- Available to use in a variety of ways
- Funding available for in-state schools only

- Additional scholarship applications
- College specific scholarships/tools
- Private funding opportunities

FAFSA - Funding For Everyone


- **★** Free Application for Federal Student Aid (FAFSA)
 - Must be completed electronically
 - Students and parents have their own FSA ID
 - New this year students must invite parents to complete the FAFSA for them (in support of them)
 - If you have another college student, or if you've completed the FAFSA at any other time before, your FSA ID is the same
 - Can apply for the FSA ID now
 - Several steps, including providing/registering a personal email, setting up two-step verification, etc.
 - Once your SS number has been matched, you will receive an email confirming your FSA
 ID

What information do you need to create an FSA ID?

FSA ID Guidance for Parents

FAFSA - Funding For Everyone

- ★ FAFSA changes this year are meant to expand Pell Grant eligibility. Also want to make the form easier to file, reducing the number of questions from over 100 to about 40.
- ★ Streamlining the use of the IRS Retrieval Tool by matching SS numbers in advance
- ★ FAFSA uses tax figures from two years prior (ex., for students enrolling in the Fall 2024, use your 2022 tax return)

FAFSA - Planning

- ★ Check the Financial Aid pages of the colleges you're considering. They should have a preferred FAFSA deadline posted.
 - University of Idaho preferred application deadline is December 1st. Students will be considered for merit scholarships based on GPA initially. File the FAFSA as soon as possible to be considered for other forms of financial aid (grants/work study/loans). Eligibility will be determined on a rolling basis.
 - Boise State preferred application/FAFSA/Scholarship application deadline remains February
 15
 - WA State University FAFSA priority deadline is March 31st; scholarship application deadline is January 31st

Idaho Scholarships

- ★ Apply through Scholarship Idaho
 - Scholarship Idaho
- ★ ID Board of Education scholarships
 - Opportunity Scholarship
 - Must have an unweighted, cumulative GPA of 2.7 or higher
 - Must complete the FAFSA by March 1st
 - Renewable for 4 years, based on satisfactory academic standing
 - Only available to use at an eligible Idaho college/university
 - Governor's Cup Academic and Career/Technical
 - Academic deadline March 1st
 - Career/Technical April 15
 - Must have at least 2.8 GPA
 - Armed Forces/Public Safety Officer Scholarship
 - Contact scholarship program manager for screening and eligibility information

Idaho Launch - Who Can Use This?

- ★ Students attending an educational program beyond high school
 - Bachelor's degree level
 - Boise State Boise State Launch Eligible Programs
 - University of Idaho <u>U of I Launch Information Page</u>
 - Lewis-Clark State University LCSC Launch Information Page
 - Associate's Degree/Workforce Training Programs
 - North Idaho College NIC Launch Information Page

Launch - What Does It Cover?

- ★ Total allocated funds per student \$8,000
 - Covers 80% of tuition/fees; student must fund, or find funding, for remaining costs
 - o If completing a multi-year program, can use up to 50% of the funding per year
- ★ Can be combined with other funding
 - Students attending a 4 year school should apply for Launch as well as the Opportunity scholarship
 - Apply as soon as possible for best chance of receiving funding
 - Your choice of study should align with the in-demand careers list as much as possible but, if you're not sure about your major, or if you shift gears after receiving funding, don't worry, it's likely your new program will fit within the parameters as well

Launch - One More Requirement

Students applying for Idaho Launch funding must also complete a Career Pathway Plan inside the Next Steps Idaho website. You'll need to do this before graduation. We'll have a separate information session for students in the spring semester to ensure this requirement is met.
